


CAPTIVE INSURANCE IN CONNECTICUT: REFLECTIONS AND THANKS HONORING OUR PAST AND CELEBRATING OUR FUTURE

As we celebrate the 10th Anniversary of the Connecticut Captive Insurance Association, we wanted to look back and thank those who helped launch the captive insurance industry in Connecticut. We proudly recall the work of the many individuals and State Officials who had the foresight and determination to start the industry and create the Association. We would not be where we are today without all of them.

In 1996, **Dominic Mazzoccoli**, who served as a State Representative for the 27th District for three terms from 1993 to 1999, introduced the first bills (SB 329 and SB 466) in support of captive insurance in Connecticut. Mazzoccoli worked for the Travelers in Hartford for over 20 years as the Director of National Accounts Property and then worked at the Housing Authority Insurance Group in Cheshire as their Vice President and Chief Underwriting Officer. Both bills were voted out of the insurance Committee but failed to pass the full Legislature. It would be another 12 years before the first captive insurance bill was passed into law launching the Connecticut captive insurance domicile and industry in our state.

Thanks to the leadership of **Tom Hodson**, **Glenn Saslow** and other captive industry leaders who lived in Connecticut, and then Commissioners of Insurance, **Thomas Sullivan** and **Thomas Leonardi**, Connecticut finally established the captive industry and continued the legacy of insurance innovation that carries on today. Many other important leaders continued to grow this important industry and need to be recognized for their work including John Thomson, Janet Grace, Stephen DiCenso and Insurance Commissioners **Anne Melissa Dowling** and **Katharine Wade**. Thanks to their dedication and hard work, the Connecticut captive insurance industry has both a proud history and a very bright future, and we salute and recognize each of them!
